- Tender Form can be obtained from office of the Inspector General, Pakistan Railways Police, CPO, Lahore before the date of opening of tender on submission of written request on Letter Head Pad of the Firm with copies of CNIC, NTN, GST numbers and Professional Tax Certificate of the Proprietor.
- The Bidders should deposit 2% Earnest Money of the quoted amount in the shape of Bank Draft from any Scheduled Bank to the name of “IG/PRP, CPO” Lahore and attach it with the Tender Form.
- The Tender Form complete in all respect be deposited/dropped either personally or sent through registered Post/Couriers so as to reach this office on or before 17.09.2025 till 1145 hours.
- The Tender will be opened on 17.09.2025 at 12.00 hours in the presence of bidders and Tender Committee members.
- Bidding will be conducted using National competitive bidding procedures as specified in the PPRA Rules–2004 (amended time to time).

- The Bidder who is on Active Taxpayer's List (ATL) of FBR will be eligible to participate in the tender. Last five year status of Tax payer be attached with bid.
 - Conditional, incomplete tender without 2% Earnest Money and Bidder(s) not fulfilling the above mentioned requirements shall be considered as non-responsive and shall stands disqualified i.e. Bidder(s).
 - The rates quoted should be valid till for a period of 120 days after the bid opening date. The successful Bidder shall give performance guarantee @ 10% of the contract amount.
 - The Bidders shall provide the samples of each item according to criteria as shown in the above table at Sagheer Police Lines, Australia Chowk, Lahore, within 10 days from the date of opening of the tenders otherwise offer will be rejected by the Tender Committee.
 - Non provision of articles as per specification/samples as declared in lab test/technical evaluation will also disqualify the bidders from the tender process and their financial proposals shall not be considered.
 - Bids can be cancelled before the award of contract without any reason as per Rule-33 of PPRA Rules.
